- There was a 35.7% increase in referrals from 2003 to 2012.
- Colorado's child fatalities due to maltreatment have declined since 2003 from 31 to 26 in 2012. This represents a decline of 16.2% over a 10 year span.
- Colorado's child fatalities due to intrafamilial maltreatment when the county department of social services had prior involvement have increased from 29% in 2003 to 35% in 2012.
- In 2003, **9** child fatalities due to intra-familial abuse or neglect had prior county involvement, compared to **9** in 2012.

Certainly, while any child fatality due to abuse or neglect is too many, it's important to note that the number of total child fatalities due to abuse or neglect has actually declined in Colorado since 2003.

The table below shows child fatalities abuse or neglect by calendar year for the past 10 years. It also displays the number of fatalities in which there was prior child welfare involvement (defined as a prior referral, assessment/ investigation or case involving the child or child's family within five years prior to the substantiated fatality for fatalities which occurred in 2003 to December 31, 2012. The fatality data shown in the chart differs from the data reported in the National Child Abuse and Neglect Data System, in that it does <u>not</u> include fatalities due to third party or institutional abuse/neglect.

The table and the following graph show that the number of referrals (reports) of child maltreatment handled by the counties grew by **35.7%** from 2003 to 2012. The total number of child fatalities due to abuse or neglect has fallen from **31** in 2003 to **26** in 2012. There were 9 fatalities with prior county involvement in 2003 and 10 years later also in 2012. Note that the percent of child fatalities that had prior county involvement has increased over this span from **29%** to **35%** of all fatalities.



The ratio between the number of referrals (Column 2) to fatalities with prior county involvement (Column 4) is extremely small. In 2003, it was **0.014%** and improved in 2012 to **0.0108%**. This indicates that even though child protection referrals increased from 2003 to 2012, corresponding child fatalities due to maltreatment with prior county involvement declined in 2012. The sharp drop from 2011 was due to a traffic accident involving 5 children that caused the number to jump. If this extraordinary year is excluded, this ratio remains relatively stable over time.
