Drought and climate unpredictability also compound and magnify the risks that communities face throughout the state, especially in the wildland urban interface (WUI). Moving forward, strategic land use planning will be essential to build community resilience by minimizing or avoiding exposure to wildfire, and other interrelated hazards. This workshop will focus on how Colorado counties can reduce their risk and vulnerability to wildfire by integrating hazard risk reduction strategies into land use planning, including integrating wildfire into the comprehensive plan, subdivision standards, and site-specific hazards assessments. The workshop will also explore how a Colorado county (Summit) has been able to successfully implement some of the land use planning tools described to reduce their wildfire risk.
