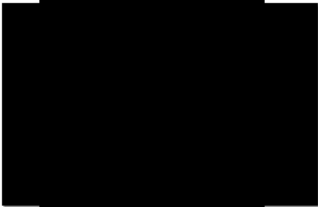





NOTICE OF PUBLIC HEALTH ISOLATION ORDER 20-01

March 6, 2020



The Colorado Department of Public Health and Environment (CDPHE or “health department”) has determined that you have 2019 Novel Coronavirus disease, referred to in this document as “COVID-19”, as described in the attached Declaration. Persons infected with COVID-19 may be contagious from prior to symptom onset through resolution of symptoms, which must be confirmed by negative test results. Pursuant to the legal authority set forth in § 25-1.5-102(1), C.R.S., this Public Health Isolation Order requires that you follow the requirements listed below until it is determined that you are not potentially infectious.

Effective immediately, to protect the public’s health and to prevent further spread of the disease, you are order to comply with all of the following requirements:

- You shall remain at the  unless CDPHE determines if there is another appropriate isolation location for you, in which case CDPHE will move you to an alternate location. You shall remain isolated until CDPHE has determined you are not potentially infectious.
- You shall allow daily contact with health care professionals who are providing your care to assess whether you continue to be infectious.
- You shall cooperate with health care professionals in the administration of necessary infection control actions.

This public health isolation order shall end only when you receive a second written order from CDPHE or its designated local public health authority that tells you the order is terminated. The second order will be issued when you are no longer at risk of transmitting COVID-19 to others. Factors that will be considered in this determination include:

- Resolution of fever, without use of antipyretic medication
- Improvement in illness signs and symptoms
- Negative test results for COVID-19 from at least two consecutive tests.



If for any reason you do not follow these requirements, public health authorities may file an action in district court to enforce this Public Health Isolation Order. § 25-1-114, C.R.S.

Immediate issuance of this Order is necessary for the preservation of public health, safety, or welfare, and the requirements of the Administrative Procedure Act, §24-72-201 *et seq.*, C.R.S., do not apply.

FAILURE TO COMPLY WITH THIS ORDER IS SUBJECT TO THE PENALTIES CONTAINED IN §25-1-114, C.R.S., INCLUDING A FINE OF UP TO ONE THOUSAND (1,000) DOLLARS AND IMPRISONMENT IN THE COUNTY JAIL FOR UP TO ONE YEAR.

DECLARATION IN SUPPORT OF PUBLIC HEALTH ORDER FOR ISOLATION

I, Eric France, do hereby declare that:

1. I am the Chief Medical Officer at the Colorado Department of Public Health and Environment.
2. Coronavirus, COVID-19, is typically spread person to person through respiratory droplets produced when an infected person coughs or sneezes. Some spread may be possible before an infected person shows any symptoms. It may be possible that a person may get COVID-19 by touching a surface that has the virus on it. Symptoms include fever, cough, and shortness of breath. The incubation period is usually 2-14 days.
3. It is my professional judgment that [REDACTED] has COVID-19, a communicable disease for which isolation is authorized pursuant to § 25-1.5-102(1), C.R.S.
4. I reached this conclusion based on the following evidence: presumptive positive laboratory test result for COVID-19 on March 6, 2020.
5. As a result, in order to contain the spread of the disease, [REDACTED] should be isolated until it is determined that [REDACTED] is not potentially infectious.

I declare that the foregoing is true and correct to the best of my knowledge and belief.

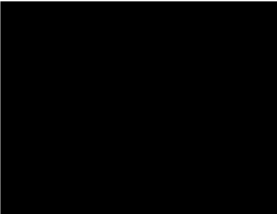

NOTICE OF PUBLIC HEALTH QUARANTINE ORDER 20-02

March 6, 2020



The Colorado Department of Public Health and Environment (CDPHE or “state health department”) has determined that you recently have been in close contact with an individual who has been confirmed to have 2019 Novel Coronavirus disease, referred to in this document as “COVID-19”. Based on this exposure, you have been identified as a person with a high risk of contracting COVID-19, which risk warrants quarantine and active monitoring by public health.

FINDINGS

1. Based on the scientific evidence collected concerning the outbreak of COVID-19, the disease meets the definition of “severe acute respiratory syndrome” as specified in federal Executive Order 13295, as amended by Executive Orders 13375 and 13674.
2. The Director General of the World Health Organization has declared that the outbreak of COVID-19 constitutes a Public Health Emergency of International Concern. The Secretary of the US Department of Health and Human Services has declared that COVID-19 constitutes a public health emergency.
3. In accord with the guidance issued by the Centers for Disease Control and Prevention (CDC) on February 3, 2020, intimate partners and close household contacts of individuals infected with COVID-19 or individuals who cared for others infected with COVID-19, and individuals who were near or in the same environment as a COVID-19 infected individual are at risk of infection and further transmission of the disease.
4. [REDACTED] is an intimate or close contact of an individual diagnosed with COVID-19, which based on CDC guidance, CDPHE defines as high risk of infection.
5. As a result, in order to contain the spread of the disease, [REDACTED] should be quarantined until a full incubation from possible exposure has elapsed (14 days since last known exposure) and it is determined that she is not potentially infectious.
6. Persons infected with COVID-19 may become symptomatic anywhere from two to fourteen days after exposure. Your last possible exposure date is March 6, 2020, so you may yet develop symptoms, such as fever, cough or shortness of breath or difficulty breathing, throughout the fourteen-day incubation period, ending on March 20, 2020. If you develop symptoms of COVID-19, you could spread the virus.

Pursuant to the legal authority set forth in §25-1.5-102(1), C.R.S., this Public Health Quarantine Order requires that you follow the orders listed below until March 19, 2020 and it is determined that you are not potentially infectious.

QUARANTINE ORDER

Effective immediately, to protect the public's health and to prevent further spread of the disease, you are ordered to quarantine in a separate room from the presumptive positive case until March 20, 2020 at the [REDACTED] unless CDPHE determines if there is another appropriate quarantine location for you, in which case CDPHE will make arrangements to move you to an alternate location. Quarantine means separating an individual or group reasonably believed to have been exposed to a communicable disease, but who is/are not yet ill, from others who have not been exposed, to prevent the possible spread of the communicable disease.

You are further ordered to cooperate with CDPHE as indicated below:

Health Monitoring

- Active Monitoring:** using a symptom and temperature log, you shall take your temperature twice daily with a thermometer in the morning and night, note any other symptoms, and record the results. If you are taking aspirin, Tylenol® (acetaminophen), ibuprofen, or any fever-reducing medicine, ensure that you take your temperature just before taking your next dose. Public health staff will contact you daily, with possible in-home visits as necessary, to monitor your health and any symptoms that might develop. You must keep these staff informed of your contact information and be available within one hour of contact by public health.
- Symptoms Identified.** You shall notify CDPHE employee Rebecca Larsen at 970-471-0112 if you develop fever (temperature greater than 38.0 degrees Celsius or 100.4 degrees Fahrenheit) or other symptoms (cough, shortness of breath, chills, body aches, sore throat, headache, diarrhea, runny nose, nausea/vomiting). If you are unable to reach anyone at the above-listed number, please contact CDPHE at 303-692-2700 business hours or at 303-370-9395 after hours.
- Medical Care.** Prior to seeking ANY medical attention in an office, clinic, or hospital, you must call and inform your healthcare providers that you are under active monitoring for potential exposure to COVID-19. You must also inform CDPHE employee Rebecca Larsen at 970-471-0112, who will inform you of precautions you must take to protect against infecting others at the time you are seeking medical attention. If you are unable to reach anyone at the above-listed number, you must contact CDPHE at 303-692-2700 or at 303-370-9395. If your condition requires calling 911, you must also inform the 911 operator that you are under active monitoring for potential exposure to Coronavirus.

Travel and Public Activities Restrictions

Public Health Quarantine Order 20-02

- You shall not travel by airplane, ship, long-distance bus, or train
- Any other travel must be coordinated with and approved by public health
- You shall separate yourself from others and avoid all public activities
- You shall not use public transportation, such as light rail, bus, or taxi
- You shall not go to work. Working from a home-based office is permitted
- You shall not go to school

Restrict visitors who do not have an essential need to be in the home
If you do not have respiratory symptoms, the public health agency may authorize limited outdoor activities (e.g. take a walk) as long as you maintain a minimum six foot distance from any other individual

Follow the terms of this Public Health Quarantine Order through March 19, 2020 (14 days after your last possible exposure), at which time you may resume all normal activities. If for any reason you do not follow these requirements, public health authorities may file an action in district court to enforce this Public Health Quarantine Order. §25-1-114, C.R.S.
