Important Things to Remember Financial Resources Available to Local Governments To Address COVID-19



Department of Local Affairs

- Federal requirements apply to all federal programs including Coronavirus Relief Funds.
- Duplication of benefits is not permitted in any federal program.
- We encourage you to have conversations in your communities about local priorities with the potential for future COVID surges in mind and CDPHE's urging to increase local capacity needs.

Colorado Department of Public Health and Environment

- Robust public health is THE thing that will keep our communities and economies safe and productive. We MUST invest in testing, disease investigation, contact tracing, and support for individuals in isolation and quarantine to beat COVID.
- Investing in public health capacity now will prevent catastrophic human and economic losses in the fall and after.
- Federal "Epidemiology and Laboratory Capacity" funds being distributed to local public health agencies need to be used to support public health containment efforts (case investigation, contact tracing, testing, and public health response activities).

Colorado Department of Transportation

- Apply for both the Revitalizing Main Streets and Community Telework Challenge grants at https://www.codot.gov/programs/community-challenge.
- Revitalizing Main Streets grants are only available to local governments and other transit or governmental agencies.
- Revitalizing Main Streets applications requesting reimbursement for work done prior to submitting the application are not eligible.

Colorado Department of Labor and Employment

- The federal government will reimburse 50% of benefits for reimbursable employers.
- Unemployment benefits are intended as economic drivers.
- Work closely with workforce boards on solutions for workers that are not able to return to their pre-COVID employment.

Colorado Department of Human Services

- Demand and need for human services grows during crisis and recession. Investment in these services, even when budgets are tight is critical.
- Work closely with your County Human Services departments, you can find contact information here: https://www.colorado.gov/pacific/cdhs/contact-your-county.
- Majority of funding available for COVID flows through existing allocation streams, but some grants do become available sporadically. Currently, the Colorado Food Pantry Grant that was created by HB20-1422 is available to support food pantries and food banks to purchase client-preferred food from Colorado producers and processors.
