

CCI & ACCA General Session Property Tax: An Evolving Revenue Stream Post Gallagher Cascade DEF

While the almost 40-year-old Gallagher Amendment had its shortcomings, the constitutionally enshrined formula provided an element of predictability for property tax dependent local governments. The repeal of Gallagher, without a viable replacement, has resulted in an annual tinkering by the state legislature of assessment rates, new property subclasses and off-the top valuation decreases. In just three short years, property taxes have become more complex, complicated and at the whim of both the state legislature and citizen initiatives. This session will highlight this year's legislative efforts (SB23-303), preview the implementation of this year's bill and last year's bill (SB22-238) and the availability of the state's expanded property tax deferral program for all Coloradoans who seek property tax relief in the short term.

The Colorado General Assembly recently passed SB23-290 which implements Proposition 122 (Legalization of Natural Medicines). The bill formally legalizes the use, possession and home growing of various natural medicines and allows for the creation of "healing centers" where individuals can take natural medicine in a controlled and supervised environment. While natural medicines (such as psilocybin and mescaline) have been used for hundreds of years by some indigenous cultures, there is a general societal lack of awareness as to their use and potential mental health benefit. This session will provide some background on natural medicines and their uses as well as a brief overview of what the operation of licensed healing centers might look like. Representatives from the Department of Revenue will also discuss the legislation in more detail, including the regulatory framework that is anticipated and licensing regime that will be established going forward.


