1862

The Morrill Act of 1862 is signed by President Lincoln

The Morrill Act granted land for the establishment of agricultural colleges throughout the U.S.

1902

4-H is created, initially started as a youth ag program in Ohio

The 'clover' emblem was designed in 1910, and by 1912 they were officially called 4-H clubs.

1967

Division of Continuing Education, today including CSU Online and Professional, established

1965

Colorado Water Center established

2006

Office of Outreach and Strategic Partnerships created at CSU to coordinate outreach and engagement efforts

2008

CSU Online launches, building on the history of remote learning offerings including VHS and CDs

2016

Provost's Council for Engagement launched

1870

The Colorado Agricultural College is established

The college would later become Colorado State University

1914

Smith-Lever Act creates the Cooperative Extension System

4-H is nationalized, and CSU Extension officially becomes part of the Cooperative Extension Service

1975

Colorado Master Gardener program started

2006

Osher Lifelong Learning Institute (OLLI) launched at CSU

2010

Office of Engagement and Extension formally established


2011
