As Colorado faces rising water demand, climate uncertainty, and shifting demographics, pressures on irrigated agriculture are mounting. This session offers an accessible primer on the interstate water compacts that affect Colorado communities, beyond the ones making headlines. Attendees will hear directly from water experts and on-the-ground practitioners about the cascading impacts of water scarcity and how they intersect with local land use planning, development pressures, and choices facing county leadership today. With a focus on practical implications, panelists will explore how compacts influence on-the-ground tensions, community-level impacts of changing water use, and the role county officials can play in long-term collaboration and planning to navigate these challenges.

## County Commissioners serving as Board of Health Members

(this session will meet annual training requirement from state statute)

In Colorado, every county must be served by a board of health that makes critical decisions about public health priorities, policies, funding and practices. Currently, over 100 Colorado county commissioners also serve their communities in the role of the county's board of health, overseeing their local public health agency's work. Colorado Revised State Statute 25-1-508 includes a requirement that all Board of Health members take annual training from the Colorado Department of Public Health & Environment. The training is designed to help the board of health members understand the best practices for the board of health members & state statutes related to public health. This session will meet the statutory requirement and include discussions, tools and time for questions. Topics include:

- Colorado' s Core Governmental Public Health Services & Capabilities
- The six functions of a board of health
- Understanding state statute related to the Community Health Assessment, Board of Health, and oversight of the local public health agency executive director
- Emergency management responsibilities of a board of health during a public health emergency
