



Note: 2025 CPD allocations are actually flat or a slight increase, but uncertainty remains, particularly for the FY26 federal budget.

## Community Development Block Grants (CDBG)



(Slide One of Three)

Supports community development activities to build stronger and more resilient communities. Funds public facilities, economic development, housing development, and disaster recovery.

## Community Services Block Grant (CSBG)



(Slide 1 of 3)

Provides formulaic grants to alleviate the causes and conditions of poverty in communities.

## Housing Choice Vouchers: What They Do



Provides tenant-based subsidies for rents paid by low-income households based upon their income.



**8,100 households**Served over a 1 year period



**6,000 low-income households**Receive rent payment support per day

### Housing Choice Vouchers



#### **Impact**

Vouchers provide safe and secure housing for the most vulnerable Coloradans. Over 80% of households served by our rental assistance programs include a person with a disability.



## Housing Choice Vouchers: Proposed Reductions 🗶 🥞





#### **Allocation**

\$440.1 Million per year

- \$83.1M to DOLA
- \$357M to local Public Housing Agencies

## Emergency Housing Vouchers (Slide 1 of 3)



Provide tenant-based subsidies for rents paid by low-income households based on their income.



Support

415 households with rent each year

## Emergency Housing Vouchers (Slide 2 of 3)



#### **Impact**

Serve extremely low-income households who are the most vulnerable, which includes individuals experiencing homelessness, at risk of homelessness, or facing domestic violence, sexual assault, trafficking, and/or stalking.



## Emergency Housing Vouchers (Slide 3 of 3)



#### **Allocation**

\$7.8 Million per year

#### **Program Cuts**





## Homelessness Programs: What They Do

#### **Emergency Solutions Grant (ESG)**

supports shelter operations, street outreach, homeless prevention, rapid rehousing rental assistance, and Homeless Management Information System operations.

#### Allocation

ESG \$3.2 Million Per Year

- \$2.M to DOLA
- \$1.1M to local governments

Continuum of Care - Permanent Supportive Housing (CoC PSH) provides rental assistance and supportive services for people experiencing homelessness and have an identified disability verified by medical professionals.

#### **Allocation**

CoCPSH \$40 Million Per Year

- \$8.1M to DOLA
- \$30.9M to local governments

## Energy-Related Programs: Microgrids (Slide 1 of 3)





The Microgrids for Community Resilience (MCR) grant program builds community resilience regarding electric grid disruptions.

#### Projects funded:

- Planning/feasibility studies
- Construction of local resilience hubs
- Microgrids for small rural towns
- Batteries to support critical regional infrastructure





29 Grants

\$16.1 Million Awarded



What is a microgrid?


A single, controllable entity that can function independently of the main electric grid.

## Energy-Related Programs: Microgrids (Slide 2 of 3)





**Impact:** Estes Park Storage and Microgrid Project will support critical community infrastructure during blackout events.



## Energy-Related Programs: Microgrids (Slide 3 of 3)






#### **Allocation**

- \$12.9 Million for Years 1-3 of Department of Energy (DOE) 40101d funding through IIJA
- \$3.5 Million in state funds from General Fund

## Transmission Siting & Economic Development




Establishes economic development grant program to support Southeastern Colorado communities impacted by the Three Corners Connector (3CC).

- Local partners will run program
- Local communities to determine use of all economic development grants

#### **Allocation**

(One-time) \$10 million investment transmission





The Three Corners Connector is a 300 mile electric transmission line that connects the Oklahoma panhandle to Pueblo, Colorado.

## **Emergency Management Grants**



The FEMA Emergency Management Performance Grant (EMPG) award supports 24 DHSEM full time staff positions and 57 county emergency management programs through a 50% cost share.

#### **Allocation**

\$6M Annually

## Good News: Low-Income Housing (LIHTC) Tax Credit

#### House

- Passed the "Big, Beautiful Bill"
- Includes several LIHTC provisions that would expand and improve the program

#### **Senate**

- Currently negotiating
- Senate leaders plan to work on the bill throughout the summer

If adopted would add 13,200 units in Colorado

- Communication with your federal representatives
- Message human impact

## Budget Cuts: Gray & Black Market Marijuana Enforcement Grant Program



#### **DISCONTINUED**

#### What it Does

This formulaic program subsidizes law enforcement costs associated with illegal marijuana cultivation/distribution including equipment, overtime, storage and disposal, and legal costs.

#### What's Next:

Open contracts expire on May 31, 2025 and May 31, 2026



## Budget Cuts: Defense Counsel on First Appearance 🛭



#### **PAUSED**

#### What it Does

This program subsidizes costs associated with the provision of defense counsel to defendants at their first appearance in municipal courts

#### What's Next

Funding paused for FY26 - may resume for FY27



## **EIAF Funds Going Forward**



- Three EIAF grant rounds were offered in FY25
- Program experiencing high volatility
- One anticipated EIAF grant round in FY26 (probably Spring 2026)
- \$15-25M in anticipated grant funding for FY26 (depending on severance tax collections)



Ouray's County Courthouse previously received an EIAF grant for renovations of the building



## Proposition 123: Fast Track Assistance

#### **Incentive Awards Available!**

**\$2M** in total incentive funding set aside for any of the eligible local governments that adopt a compliant expedited development review process *early*.



## DOLA's Al Pilot: Plan Review



DOLA will partner with Archistar, funded by Gary Community Ventures, to launch a pilot for AI plan reviews for **Building Codes & Standards**.

This three month pilot aims to reduce plan review processing time and lower costs for developers and re-reviews

Re-reviews are currently at 17%



## DOLA's AI Pilot: Local Government Partnership

### **Taking the AI Pilot One Step Further**

- Working directly with local government(s)
- Leveraging Local Capacity Grant funds
- City of Greeley is confirmed to explore an AI pilot project focused on lowering permit review times.
- Al Pilot Cohort with 3-6 communities
  - Goal is to design a pilot that is replicable to other local communities

\$204,700 Available

Technical assistance and Annual Mini Grants to support economic development of Main Street Communities

Rural Economic Development Initiative (REDI)

\$780,000 Available

Annual funding to help rural communities comprehensively diversify their local economy and create a more resilient Colorado.

Proposition 123 Local Planning Capacity Grant

\$6.5M Available

Supports local government implementation of Prop 123 requirements including fast track and planning affordable housing strategies or projects.

## Funding Opportunities (Continued)



**Housing Planning Grant** 

No Suggested Min/Max - \$12M in Total Program

To comply with SB24-174 and support development of a new Housing Needs Assessments, Housing Action Plans, or Strategic Growth element of comprehensive plans.

Transit-Oriented Communities Infrastructure Grant

\$35M Total Program Funds Available

For certified TOC communities and Neighborhood Centers (HB24-1313). Pilot round expected Fall 2025.

**CHFA Low-Income Housing Tax Credit Program** 

[\$30M Total Through 2029]

Helps finance low income rental housing projects, especially near transit centers.




